The Buyer/Planner is responsible for the execution and continuous improvement of the planning/order fulfillment process for one or several product lines covering both demand planning and order fulfillment as well as supply planning and materials replenishment. This is a 6-month contract position with potential conversion to a permanent position. Healthcare and other benefits are provided.

Responsibilities include but are not limited to:

- **Demand planning & order fulfillment**
 - Manages order backlog after order entry ensuring that orders flow through the order fulfillment cycle
 - Manages inventory (for the commodity managed)
 - Manages open POs and suppliers by commodity
 - Validates order configuration
 - Maintains and communicates order delivery dates
 - Plans Production parts in accordance with manufacturing production requirements
 - Works to drive on-time delivery to the customer
 - Partners with other functions (Manufacturing, Engineering & Finance) to resolve/escalate any issues preventing on-time order fulfillment
 - Partners with finance to monitor accurate revenue recognition on assigned orders.

- **Supply planning and materials replenishment**
 - Executes planning process, creates purchase orders and communicates with suppliers.
 - Reviews (daily) and resolves material shortages
 - Reviews (daily) open purchase orders, expedites past due orders, and obtains supplier promise dates
 - Ensures materials are available on-time while simultaneously minimizing inventory
 - Maintains accuracy of planning parameters in the MRP system
 - Drives improvement in supplier on-time delivery
 - Interacts with key suppliers
